#### Common Core Standards Presentation

Associate Superintendent of Educational Services, Gail Baxter and Martha Mestanza-Rojas, Los Altos School principal, presented an overview of Common Core Standards. Common Core Standards are a state-led effort to give all students the skills and knowledge they need to succeed. The standards provide a consistent and clear understanding of what students are expected to learn to succeed in college and careers in the 21st century. This summer a group of dedicated teachers, headed by Mrs. Mestanza-Rojas, with the aide of the coaches, Ms. Baides, Ms. Kivi and Ms. Merrill, teamed together to learn about the background and goals of the Common Core Standards. This team will continue to meet quarterly. These standards will be implemented by 2014, as reported by Mrs. Baxter.
