The Education Code requires that all Special Education Local Plan Area's (SELPA's) maintain a Community Advisory Committee (CAC). The CAC is an advisory group that provides input to the SELPA's Local Plan. The committee is composed of parents of students with disabilities, general and special education teachers, specialists and other school personnel or representatives of community agencies concerned with the needs of individuals with disabilities. According to the Education Code, one half or more of the CAC members shall be parents of students in school districts. CAC membership shall be appointed by governing boards of the Local Plan and appointment shall be for a period of two years.

The district is prepared to present nominations to the governing board for approval. The following names, with their position, are submitted to the board as district representatives for the period of August 01, 2020 through June 30, 2022 on the Whittier Area Cooperative Special Education Program Community Advisory Committee.

#### 12.2. PUBLIC HEARING: 2020-2021 Proposed Budget

A public hearing is in order to provide an opportunity to comment on the South Whittier School District 2020-2021 Proposed Budget.

The Education Code requires school districts to adopt a budget and submitted to the County Office no later than July 1st of each fiscal year. The Adopted Budget reflects the estimated actual expenditures through June 30, 2020 along with the adopted budget for 2020-2021 fiscal year.

This proposed budget was developed using the state-adopted Criteria and Standards. It includes the expenditures necessary to implement the Local Control and Accountability Plan (LCAP) and annual update to the LCAP that will be effective for the budget year. Upon the Board's approval, the budget will be filed and adopted subsequent to a public hearing by the governing board of the school district pursuant to Education Code sections 33129, 42127, 52060, 52061, and 52062.

#### 12.3. Adoption of the 2020-2021 Budget

The Public Hearing for the 2020-2021 Proposed Budget was also held at the June 23, 2020 Board meeting.

The Superintendent recommends the Board of Trustees:

1. Adopt the 2020-2021 Budget as presented.

2. Recognize in adopting the 2020-21 Budget, the Board understands its fiduciary responsibility to maintain fiscal solvency for the current and subsequent two fiscal years. At this time, there is a high degree of uncertainty due to COVID - 19, the State's reduction or delay of Districts' revenue, and the rate of economic recovery, which would implement proposed trigger reductions for 2020-21 and beyond. With the 2020-21 Budget submission, the Board is provided with a 2020-21 budget stabilization plan.

Furthermore, in the event that the revenue cuts take place beyond 2020-21 and/or increased costs to provide education services to our students under new COVID – 19 requirements, the District's budget shortfall is approximately an additional \$3 million per year as reflected in form MYP of the budget. The Board acknowledges that the District has addressed the need for a contingency plan with the appropriate Board options by which to address this potential reduction in funding/increased expenditures. This plan will allow the District to maintain fiscal solvency for both 2021-22 and 2022-23. The sum of all the measures within the budget stabilization plan for 2021-22 and 2022-23 fiscal years are included in the other adjustments row of the form MYP as well as in the expenditure section. A more refined and specific plan will be reevaluated with the District's 2020-21 First Interim based upon the budget planning recommendations issued by the Los Angeles County Office of Education. Any additional updates to that plan will be dependent on the final adopted 2020-21 State Budget, including any revisions in August 2020.
