# 12.1. Adjustment to 2019-2020 Unaudited Actuals

The state has allowed local education agencies to account for all expenditures related to COVID-19 since March 2020 for learning loss mitigation funds, in the 2019-20 fiscal year, however the state is silent on recognizing the related Learning Loss Mitigation (LLM) revenues. Subsequent to the approval of the 2019-20 Unaudited Actuals report during the September 8 Board of Trustees meeting, the Los Angeles County Office of Education (LACOE) has directed that the District should not recognize revenues for LLM funds but rather should close the books reflecting a negative resource and restricted fund balance. After consulting with the District's independent auditors, the 2019-20 Unaudited Actuals report was revised to reverse the accrued LLM revenue and close the books with negative restricted fund balance as directed by LACOE. The revision does not have any effect on Unrestricted Fund Balance or reserves.
