Executive Summary:

At the end of each fiscal year, the books of the District are closed. Closing the books is the record keeping process where revenues and expenditures are adjusted to reflect final balances for the fiscal

year. The Unaudited Actuals financial reports are then prepared in a format required by the California Department of Education. Education Code 42100(a), requires school districts to adopt the Unaudited Actuals by September of each year.

Financial Condition:

The district's accounting records for fiscal year 2019-20 were closed in August 2020. The General Fund is the largest and most important operating fund of the district. The Unrestricted General Fund is used for general education expenses such as classroom teacher salaries while the Restricted General Fund is used for specific state, federal, and local programs.

The district has a positive financial status at the end of 2019-20. The District met the minimum Reserve for Economic Uncertainties of 3% of expenditures and other uses.

12.3. Amendment to Facilities Use Agreement

On or about January 2020, the District entered a Facilities Use Agreement ("Agreement") with A & D Transportation L.P. ("A & D"), through which the District authorized A & D to park and store its buses at District property ("Premises") under the terms and conditions set forth in the Agreement and the Civic Center Act. Pursuant to the Agreement, A & D is authorized to park and store eight (8) buses at the Premises; however, A & D currently only parks and stores six (6) buses, leaving two (2) spaces unused.

A & D approached the District about sharing its use of the Premises with New Company, which desires to park and store buses in the two (2) spaces currently granted to but unused by A & D. District, A & D and New Company now desire to enter this First Amendment to the Agreement, wherein District will authorize A & D and New Company to share the Premises under the same terms and conditions set forth in the Agreement.

The Superintendent recommends that the Board approve this First Amendment to this Facilities Use Agreement.
