On September 20, 2023, Governor Gavin Newsom signed Senate Bill No. 553 (SB553) into law, a crucial step in enhancing workplace safety. This law mandates California employers to prevent and respond to workplace violence. SB553 adds Section 6401.9 to the California Labor Code, effective July 1, 2024, requiring covered employers to adopt a comprehensive workplace violence prevention plan.
